Sir,—Referring to letter I had the honor to address to you on 16th ultimo in reply to your inquiry as to the terms on which this Bank would be willing to advance two thousand three hundred pounds (£2,300) to the New Plymouth Provincial Government on the security of Debentures authorised by an Ordinance passed by the Provincial Council, intitled the "Loan Ordinance, 1857"; I have now the pleasure to acquaint you that the Bank will be willing either to undertake the negotiation of the

Loan in question by sale of the Debentures at a charge of 1 per cent. commission, which charge will cover all cost of placing the proceeds of such sale here at the disposal of the Government; or, should the repayment of the Loan be practicable within a reasonable period, the Bank would be desirous of meeting the views of the Government by advancing the sum required on *Cash Credit* or *Overdrawn Account* at the rate of 8 per cent., per annum, secured by said Debentures.

In the event of the latter mode being preferred, I should feel obliged by your informing me of the period within which the advance would probably be liquidated—or if by instalments, in what sums? and at what intervals?

Sir,—I have delayed replying to your letter of the 21st December last in order that the Superintendent before accepting either of your offers might lay them before the Provincial Council, and I have now the honor by his direction to inform you that the Provincial Government will accept your offer of the *Cash Credit* or *overdrawn account* at the rate of 8 per cent., per annum,

secured by Debentures to be issued under the Loan Ordinance of the Province.

The Government is not prepared to give you definite information as to when and in what amounts the Loan will be required, but it anticipates that no portion will be required for the next three months and that then, if an iron bridge should be decided upon, a credit or draft upon London for £1000 would be required, but if a wooden bridge is to be erected the drafts on account of the loan would probably not exceed £300 per month. And it is calculated that the whole amount will be repaid say by six monthly instalments within an average period of three years from the dates of the advances.

It is proposed to remit to you from time to time Debentures to cover the amounts required for the ensuing month, with a request to you to place the amount of the same to the credit of the Provincial Treasurer, whose cheques would be countersigned by the Treasury Clerk.

The Superintendent will be glad to be informed if the above arrangements meet with your approval.

Sir,—In reply to your communication of the 19th ultimo respecting the refusal of certain Natives to allow a deviation of the Devon Road by which it has been proposed to avoid the Mangaone hill, I have the honor to inform you that the proposed deviation crosses land the sale of which to the Crown has always been disputed by the Natives in question, and over which it unfortunately appears doubtful whether the Native Title has been properly extinguished.

The officers of the Native and Land Purchase Departments have hitherto failed in their efforts to overcome this opposition. These efforts will however be continued and if your Honor is able to suggest the use of any proper means as yet untried to the desired end, I will again bring the matter under the consideration of His Excellency the Governor.

Sir,—I have the honor to inform you that the surplus of the Ordinary Revenue of the year ended 30th June, 1857, distributable amongst the Provinces, will considerably exceed the amount of three eighths of the Gross Customs Revenue, fixed by the "Appropriation Act, 1856," as the minimum amount of the distributive shares of the Provinces for that year.

The sum of fifty-five thousand pounds has consequently been carried to the credit of the Provinces as ascertained surplus for that year—an inconsiderable balance being

reserved until the final closing of the accounts of the period.

Herewith, I enclose a statement shewing;—

1. The actual receipts by each Province on account of surplus Ordinary Revenue for the year ended 30th June, 1857.

2. The amount of the Dividend now carried to the credit of each Province on the same account.

3. The excess of such Dividend over the actual receipts by each Province on the same account.

Directions will immediately be given for

payment to the Treasurers of the Provinces of Auckland and Wellington of the amounts due to those Provinces in respect of such excess.

In the case of the other Provinces, as it is probable they will all appear debtors to the Colony, in respect to the period antecedent to 30th June, 1856, no such payment will at present be made.

WHEREAS by an Act of the General Assembly of New Zealand intituled the "Superintendent's Deputy Act, 1856" it is amongst other things enacted that it shall be lawful for the Superintendent of any Province by Proclamation to be published in the *Government Gazette* of such Province to appoint such person as he may think fit, being a registered elector of such Province to be his deputy, and as such to perform and exercise all the acts and powers (except such powers as are conferred by the Constitution Act, 15 and 16 Vic., c. 72) which may be exercised and performed by such Superintendent, or such of them only as shall be specified in such proclamation. Now therefore, I, the Superintendent of the Province of New Plymouth Do hereby appoint

WILLIAM HALSE, Esquire,

to be my Deputy during my absence from the said Province, and as such to perform and exercise all the acts and powers appertaining to the office of Superintendent except such as are conferred by the Constitution Act.

NOTICE.—In exercise of the powers vested in me by an Ordinance of the Superintendent and Provincial Council of New Plymouth, intituled "An Ordinance to regulate the Municipal Police of the Town and Province of New Plymouth" I the Superintendent of the said Province Do hereby give notice and declare that the Footway on the South side of Devon street between Currie street and Hobson street in the Town of New Plymouth—such footway being of the width of eight feet, more or less, and being defined by posts—shall henceforth be deemed and taken to be a Public Footpath within the meaning of an Ordinance of the Lieutenant-Governor of New Zealand and of the Legislative Council thereof, intituled "an Ordinance to provide for the protection of Footpaths in the Colony of New Zealand," and shall be protected accordingly.
