PROCLAMATION.

By GEORGE CUTFIELD, Esquire, Superintendent of the Province of Taranaki.

WHEREAS in the ninth Session of the Provincial Council of Taranaki held in the twenty fourth year of the reign of Her Majesty Queen Victoria, an Ordinance was passed intituled the "Consolidation Ordinance, 1860," and whereas the said Ordinance was on the 24th day of November, 1860, presented to me for the assent of His Excellency the Governor and was then reserved by me for the signification of His Excellency's pleasure thereon, and whereas His Excellency has been

pleased to assent to the said Ordinance, Now, therefore, I do hereby proclaim that His Excellency Colonel THOMAS GORE BROWNE, the Governor of New Zealand, has assented to the said Ordinance, and that I received the signification of His Excellency's assent on the 5th day of February, one thousand eight hundred and sixty one.

Given under my hand at New Plymouth this eleventh day of February, one thousand eight hundred and sixty one.
